Created in 2002, the Foundation is a 501 (c) (3) nonprofit organization that provides funding for:

- Scholarships up to \$5,000 to help students in alternative programs pursue college or career/technical schooling
- Monetary awards of up to \$1,000 to support apprenticeships or related career training
- Research and development to improve educational opportunities and practices for students

The Foundation's fiscal year is July 1 through June 30.

We work with, but are independent of, the Monroe 2-Orleans BOCES.

The Monroe 2-Orleans Educational Foundation is overseen by a volunteer board of trustees. No officer or trustee receives any form of compensation.

The Monroe 2–Orleans Educational Foundation serves students in nine school districts in Western Monroe and Eastern Orleans Counties.

Everything that I have learned during my journey at WEMOCO has made me more outgoing and professional. I used to be a very reserved and anxious individual, too nervous to do many things around other people,



especially if it meant demonstrating or working out in front of others. Now that I am almost done with my two years at WEMOCO, learning how to teach people exercises, working out, and creating plans, I have really opened-up and matured to a point where I feel prepared to move on in life. The skillsets I have developed in Exercise Science have prepared me to the best of my ability to become a physical therapist one day. In addition to what I have learned in class, WEMOCO provided me with a co-op to gain handson experience and shadow physical therapists. All these experiences and opportunities have helped me better prepare for college and my future.

ETHAN S. (BROCKPORT)

Since attending Westside Academy, I have seen a few important changes within myself. As I became more comfortable at the school, I started to become close with the staff. Most of the teachers took the initiative to utilize individual time to help me learn the information as well as how to use it in the real world. After the COVID pandemic, I felt like I lost all



my communication skills. When school started again, I wanted to make a change in who I am and what I want in life. I am dyslexic and have attention deficit disorder and am proud to share that I am graduating with a Regents diploma and heading to college. My path has not been traditional, and if it wasn't for all the alternative supports that were put in place for me, I would not have been able to achieve my goal of graduating. Being dyslexic made reading and writing



very difficult. However, I never let it define me. There are two options: making excuses or making progress, and I have always chosen the latter. In middle and high school, I had a Consultant Teacher and resource room that made sure I had necessary accommodations, and I was able to take advantage of assistive technology provided by BOCES. Because I had these supports, I was able to earn nine college credits from Monroe Community College, participate in the Architecture Construction and Engineering Program, and was accepted into all the colleges I applied to.

MANY PATHS TO GIVING

The Monroe 2–Orleans Educational Foundation is a 501 (c) (3) nonprofit organization. Gifts to the Foundation are tax deductible. There are many ways to positively impact our students by donating to the Foundation:

Bequests, Life Insurance, Retirement Plans

These options allow donors to make gifts using assets upon their death. Bequests allow you to designate a specific amount, a percentage of your estate, or all of what remains after you consider others. Bequests will allow you to reduce estate taxes. The Foundation may also be named as the beneficiary of a life insurance policy, or be given a retirement plan principal or income.

Cash Gifts

Most donors make their gifts and pledge payments by check or cash. For tax purposes, the gift date is the postmark date on the envelope, or the date the check is hand-delivered.

Charitable Gift Annuities (Life Income)

Making a life income gift can allow you to maintain or increase your income. This income can be paid to you, and then to your spouse or another individual for his or her lifetime. You receive the immediate tax benefits, and the Foundation receives your gift when the life income payments are complete.

Commemorative Gifts

Contributions to the Foundation are a great way to recognize a special individual or commemorate a significant event. The Monroe 2–Orleans Educational Foundation gladly accepts gifts made in honor or memory of an individual. Special recognition giving cards are available.

Corporate Matching Gifts

You may be able to double or triple your gift if you work at or are retired from a company that has a matching gifts program. Please contact your employer's human resources office for forms and information.

Gifts of Appreciated Securities (Stock Gifts)

Tax laws allow you to give appreciated securities and take a tax deduction for current value, and generally bypass capital gains taxes that would be due if you sold them, making it more cost-effective to contribute a gift.

Qualified Charitable IRA Distribution

A qualified charitable distribution is a charitable contribution from an IRA made directly to an eligible charity. The owner of the account isn't taxed on it which gives your donation added impact for the Foundation. Please contact your financial and/or tax advisors for further guidance on this type of donation.

Real Estate

Your home, land and other real estate may be used to make an immediate or life income gift. As with appreciated securities, real estate gifts held more than a year can offer significant tax benefits. The value of your gift will need an appraisal, required by the IRS.
